

GUIDELINES FOR FINANCIAL ASSISTANCE

The Muster 2018 will offer financial assistance to interested parties who have submitted an abstract AND are residing or working in low to lower-middle income countries.

Financial assistance may be awarded in the form of Complimentary Registration or a Discounted Registration rate.

The World Bank assigns the world's economies into four income groups — high, upper-middle, lower-middle, and low. This assignment is based on GNI per capita calculated using the Atlas Method. The units for this measure and for the thresholds is current US Dollars.

See the Appendix at the end of this document for a list of countries currently classified by The World Bank as lower or lower-middle income.

The applicant should complete the attached form to apply.

FINANCIAL ASSISTANCE CRITERIA

To be eligible for **Complimentary Registration**, you must meet the criteria below.

- You submitted an abstract prior to the deadline of Monday, 30 April, 2018;
- You are residing or working in a low or lower-middle income country;
- You would be unable to attend the Conference without financial support:
- Participation in the Conference will clearly contribute to your professional development; and
- You are not supported by an organization.
- Complimentary registrations are non-transferable.
- Applications must be submitted by the deadline of 5pm AEST, Friday, 15
 June, 2018.

To be eligible for a **Discounted Registration** rate, you must meet the criteria below.

- You submitted an abstract prior to the deadline of Monday, 30 April, 2018;
- You are residing or working in a low or lower-middle income country;

- Discounted registration rates are non-transferable.
- Applications must be submitted by the deadline of **5pm AEST**, **Friday**, **15 June**, **2018**.

PRIORITY WILL BE GIVEN TO

- Delegates for whom the cost of attending is a barrier
- Delegates residing or working in a low to lower-middle income economy as defined by The World Bank. See Appendix A for a list of applicable countries as determined by The World Bank in 2018.
